



## **Drug Free/Zero Tolerance School Policy**

Fullerton Dental Assistant School is committed to protecting the safety, health and well-being of all employees and students in our school. We recognize that alcohol and drug abuse pose a significant threat to our goals and have established a **DRUG FREE/ZERO TOLERANCE** environment.

### **COVERED INDIVIDUALS**

Any employee(s) that conducts business on the school's premises or on the school's behalf, it includes any and all students and individuals that are on the premises to provide support for any student as a part of the class curriculum that is required.

### **PROHIBITED BEHAVIOR**

It is a violation of our drug free school policy to enter the premises and be actively under the influence of alcohol or drugs, to use, possess, sell, trade and/or offer for sale controlled substances or alcohol. The presence of an amount of any controlled substance that results in a positive test is prohibited.

### **CONTROLLED SUBSTANCES**

As used in this policy, controlled substances include any drug that is illegal under federal or state law, or that is legally obtainable but has not been legally obtained. The term includes prescribed drugs which are not being used for the prescribed purpose or in the prescribed manner. Examples include but are limited to:

**\*\*\*Marijuana for medical use is a schedule I controlled substance by the DEA and therefore is prohibited.**

If you are found to be under the influence of any substance as indicated in this policy, you will be asked to leave the premises. Any missed classes will need to be repeated at students' expense and at a time that is feasible for the school.

Continued use after you have been notified of the offense by school administration may result in expulsion.

We reserve the right to refuse service to any person who violates school policy.
